COMPETITION REGULATIONS:

- ORGANISER: The Competition is organised by Międzynarodowe Targi Gdańskie Spółka Akcyjna [Gdańsk International Fair Joint Stock Company] with its registered office in Gdańsk, Poland, ul. Żaglowa 11, entered into the Business Register of the National Court Register (KRS) run by the District Court Gdańsk-North in Gdańsk, 7th Commercial Department of the National Court Register [Sąd Rejonowy Gdańsk-Północ w Gdańsku VII Wydział Gospodarczy Krajowego Rejestru Sądowego] under KRS No. 0000038362, VAT No. PL 5840253705, Statistical No. (REGON) 001363012, share capital of PLN 39,171,700 (hereunder referred to as: the "Organiser").
- 2. **DURATION**: The Competition is held within the territory of the Republic of Poland and continues between 9 May 2023 and 19 September 2023.
- 3. - 7. **WINNERS** will be selected in a polling format via nominations of journalists, editorial teams and programme series about rail transport, based on questionnaire forms submitted by voters.
