- 1. Szczęśliwicka 62 (hereunder referred to as the Foundation)
 - a. for the purposes resulting from the legitimate interests of MTG and the Foundation, i.e. for the purposes of direct marketing of MTG and the Foundation,
 - b. for the information and promotion purposes of the Competition as part of the TRAKO Fair organised by MTG in 2023 and in two subsequent years, in accordance with Articles 6.1.a) and f) of the Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016 on the protection of natural persons with regard to the processing of personal data and on the free movement of such data, and repealing Directive 95/46/EC (General Data Protection Regulation) (EU OJ L 119, p. 1—hereunder: "GDPR").
- 3. Having my child's image used, especially through:
 - a. my child's image being recorded (fixated) in photographs and video recordings,
 - b. the copies, in which the image has been recorded (fixated), being circulated,
 - c. the recorded (fixated) image being reproduced by any technique or method,
 - d. my child's image being disseminated and published by MTG, also alongside the images of other persons recorded (fixated) during the delivery of the Competition, in materials used to popularise the subjects presented during the Competition and the Fair, especially on the Internet (including MTG's social media profiles), in the press, on the radio, TV, in brochures, leaflets, newsletters, at exhibitions, competitions, on billboards, invitations and other promotion and information materials.

 - a. the consent I have given is free of charge and, moreover, I waive all and any rights to each time control and approve the use of the materials with my child's image, including if they are used for the purpose of being combined with other images by means of digital technologies.
 - b. I have been informed that my child's image and personal data in the form of my child's voice and first and last name will be disclosed publicly, which is why it is not possible to determine in advance the size of the public for the said personal data. It cannot be ruled out that entities with their registered office or domicile outside of the European Union or the European Economic Area, which may not ensure an appropriate level of personal data protection or suitable safeguards, or as to which the European Commission has not decided on an appropriate level of personal data protection, may find out about my personal data. I realise the risk involved with it, including the risk of a security breach on my child's data or their unlawful processing by the said recipients and I give my consent to the data being processed in the way and for the purposes set forth in this document.
 - c. I represent that I have provided this consent freely and that the data which I have provided is correct.

d. I have been informed that:

- 1. Międzynarodowe Targi Gdańskie SA [MTG SA Gdańsk International Fair Co.] with its registered office in Poland, 80-560 Gdańsk, ul. Żaglowa 11, KRS No. 0000038362, is the controller of my and my child's personal data (hereunder: "Data Controller"),
- 2. my child's personal data will be processed for information and promotion purposes associated with the Competition as part of the TRAKO Fair organised by the Data Controller in 2023 and in the subsequent years,
- 3. the personal data are processed based on: GDPR Article 6.1.a) (i.e. freely given consent) and GDPR Article 6.1.f) (i.e. legitimate interests of the Data Controller); the legitimate interests of the Data Controller include direct marketing purposes of the Data Controller, in particular information and promotion purposes of the events listed in the statement above, organised by the Data Controller in 2023 and in the subsequent years,
- 4. the recipients of the personal data may include the organisers, participants (including entities which work with MTG at promoting and organising the Competition and the Fair) and the public of the Competition as part of the TRAKO Fair organised by the Data Controller in 2023 and in the subsequent years,
- 5. the personal data will not be transferred to any third countries or international organisations; however, due to the public disclosure of personal data, it cannot be ruled out that entities with their registered office or domicile outside of the European Union or the European Economic Area, as to which the European Commission has not decided on an appropriate level of personal data protection, may find out about the personal data,
- 6. the personal data will be stored by the Data Controller for a period necessary to pursue the legitimate interests of the Data Controller as specified in Clauses 2 and 3 above or until this consent is withdrawn by me,
- 7. I have the right to request from the Data Controller access to and rectification or erasure of my child's personal data, or restriction of processing of his/her personal data, or to object to such processing, as well as the right to data portability; these rights may be limited only pursuant to universally applicable laws and only in the scope specified therein,
- 8. I have the right to lodge a complaint with the President of the Polish Personal Data Protection Authority (UODO), which is an independent supervisory authority referred to in GDPR Article 4.21,
- 9. I have the right to withdraw this consent at any time, without affecting the lawfulness of processing based on the consent before its withdrawal;
- 10. this consent to the processing of my child's personal data has been given by me freely and does not result from a statutory or contractual requirement; however, the providing of this consent is a condition to properly meet the purposes specified in Clauses 1 and 2 above,
- 11. the personal data will not be subject to automated decision-making, including profiling,
- 12. if the Data Controller wants to use the personal data for a purpose other than that in which they have been provided, prior to such processing the Data Controller shall inform me about that other purpose and provide me with all and any legally required information.
