

COMPETITION REGULATIONS

Draisine team race 15th International Railway Fair TRAKO

19-22.09.2023 r.

§1 Organizer

1. The organizer of the Draisine team race – KRYSZTAŁOWA SZYNA 15th International Railway Fair TRAKO (hereinafter referred to as "**the Competition**") is the Gdańsk International Fair Joint Stock Company with a registered office in Gdańsk (hereinafter referred to as "**the Organizer**").

§2 Date and place

1. The competition shall be held on track no. 500 within the area of Gdańsk Zaspą Towarową station on equipment prepared by the Organizer.
2. The competition shall start on Tuesday, September 19, 2023 at 11:00 a.m. and shall last until September 22, 2023 until the last team finishes the ride.
3. The competition shall be held from 11:00 a.m. to 4:00 p.m. on September 19-21 and from 11:00 a.m. to 3:00 p.m. on September 22.

§3 Organization of the Competition

1. The Competition shall be attended by teams consisting of exactly 4 players, who will appoint a team captain from among themselves.
2. Teams may register for the Competition by completing the form, which is attached as Appendix No. 1 to these Regulations with the Judging Committee on 19.10.2023.
3. The team that fails to report at the start on the specified date shall be subject to disqualification, without the right to start at a later date.
4. The starting order of the teams will be determined by the chief judge.
5. The competition consists in timely driving of the designated route by the team using a draisine provided by the Organizer.
6. Each competing team is entitled to only one ride.
7. All teams shall use the same handcar provided by the Organizer.
8. Competition will be held in the Open category.
9. The Organizer shall appoint the main judge of the Competition, who shall have at his/her disposal persons who will co-create the judging committee and watch over the course of the Competition, as well as the Secretary of the Competition drawing up the ranking list of the teams.

10. The Organizer reserves the right to change the schedule of the Competition or cancel it completely in the event of unfavorable weather conditions or irreparable damage to the dreisine

§4 Participation

1. Each participant of the Competition is bound by these Regulations.
2. Participants are obliged to observe public order, instructions of the Organizer and respect for other Participants. The Organizer shall have the right to remove from the area of the Event persons who disturb public order, the course of the Event or behave contrary to these regulations.
3. By declaring participation in the Competition, the competitor agrees that the Organizer may use his/her image for informational, promotional and marketing purposes.
4. Each competitor takes part in the competition at his/her own risk. Team captains are required to verify the health status of the competitors entered in the team, including the team captain is responsible for ensuring that each member of his team is not under the influence of alcohol or any other intoxicating substance. Notwithstanding the above, the Organizer reserves the right not to allow participants who are suspected to be under the influence of alcohol or other intoxicating substances to participate.
5. Only entities that are exhibitors at the event entitled "15th TRAKO International Railway Fair" may participate in the Competition.
6. Each exhibitor may enter only one team.

§5 Competition rules

1. The competition shall be held under the following rules:
 - a. the route of the ride is determined on a section of track, 2x250m;
 - b. four players of the team take their place on the handcar standing at the starting point, at the command "start" - the handcar starts;
 - c. time measurement begins at the start command;
 - d. after the line marking the halfway point, the handcar must stop and turn around in the designated zone (15 m);
 - e. crossing by any axis of the vehicle the end line of the sector of the halfway point, which is to be turned back, will result in adding of 30 seconds penalty.
 - f. stopping the handcar after crossing the finish line should take place in the designated 10-meter sector.
 - g. stopping the drainpipe in the light of the starting platform will be rewarded with deduction of 10 seconds from the final result;
 - h. crossing the end line of the stopping sector with the axle of the drainpipe will result in a 30-second penalty. After both dreisin axes cross the finish line, the chief judge shall stop the timing.

- i. the classification is determined by the shortest time obtained in both directions, after taking into account any penalty seconds;
2. Each participant may start in only one team.
3. derailment of a draisine regardless of the reason will result in disqualification of the team.
4. In matters of dispute, the chief referee shall have the casting vote.
5. The team in which there will be at least one woman will receive a gratification in the form of deduction of 30 seconds from the final score.
6. the Team, the composition of which will be at least one member of the board of directors of the company in question receive gratification in the form of subtraction of 30 seconds from the final score.

§6 Prizes

1. The first three teams that achieve the best result will receive a statuette.
2. Each competitor will receive a commemorative medal.

§7. Additional information

1. The Organizer, all persons cooperating with him, as well as persons involved in the conduct and organization of the Competition shall not be liable to participants for accidents, possible collisions, personal injury, property damage and property damage that occur before, during or after the Competition caused by the participants.
2. Participants shall bear civil and legal liability for damage caused.
3. The Organizer reserves the right to amend the provisions of these Regulations.

§8 Processing of personal data

1. The Administrator of your personal data is Gdańsk International Fair S.A. with its registered seat in Gdańsk (80-560) at 11 Żaglowa Street, entered into the Register of Entrepreneurs kept by the District Court in Gdańsk, VII Economic Department under KRS number 0000038362, NIP 584 025 37 05 with share capital of 40,332,200.
2. Contact with the Administrator is possible in writing at the address indicated in Section 1 and by e-mail at do@mtgsa.com.pl.
3. Your personal data will be processed for the purposes of:
 - performance of the concluded contract - on the basis of Article 6(1)(b) RODO, i.e. the processing is necessary for the performance of the contract to which the data subject is a party, or to take action at the request of the data subject prior to the conclusion of the contract,
 - the performance of legal obligations, including making tax settlements and keeping accounting records - on the basis of Article 6(1)(c) RODO, i.e. processing is necessary for the fulfillment of legal obligations incumbent on the Administrator,
 - the possible establishment, investigation or defense of claims between you and the Administrator - on the basis of Article 6(1)(f) RODO, i.e. on the basis of the legitimate interest pursued by the Administrator, which is the possibility of asserting claims,

- archival (evidential), which are the realization of the legitimate interest of securing information in case of a legal need to prove facts, to demonstrate the fulfillment of obligations - on the basis of Article 6(1)(f) RODO.
 - indicated explicitly in the voluntary consent - to the extent and purpose specified in the content of the consent.
4. Your personal data may be disclosed to our IT service providers, entities providing security services for the AMBEREXPO facility, consulting, legal, accounting services, entities authorized by law, e.g. police, tax authorities, court, prosecutor's office, customs authorities, and our subcontractors acting on our behalf.
 5. Your personal data may be disclosed to entities and authorities authorized to process such data under the law.
 7. The Administrator does not intend to transfer your personal data to countries outside the European Economic Area or to an international organization.
 6. 7 The period of processing of your data is as follows:
 - with regard to the performance of the contract concluded by you with the Administrator, i.e. participation in the Fair or any other event organized by MTG, your personal data will be processed for the duration of the contract until its completion and settlement, and for the period in which the provisions of generally applicable law require the Administrator to store the data,
 - in terms of carrying out the Administrator's operational activities, including statistics and reporting, personal data will be processed until the existence of the Administrator's legitimate interests that form the basis for such processing, and for the period of time during which the Administrator is required by law to retain the data,
 - for archival (evidential) purposes, which are the realization of our legitimate interest in securing information in the event of a legal need to prove facts, demonstrate the fulfillment of obligations - until the existence of the Administrator's legitimate interests constituting the basis for such processing, as well as for the time during which regulations prescribe that the Administrator store the data.
 - for the purposes indicated in the voluntary consent - for the period indicated therein or until the consent is withdrawn - whichever occurs first.
 8. After the expiration of the above periods, personal data will be stored until the statute of limitations for any claims.
 9. You have the following rights: the right of access to data concerning you, the right to rectification, erasure, restriction of processing, the right to object to data processing, the right to personal data portability.
 10. To the extent that the basis for the processing of your personal data is consent, you have the right to withdraw it. The withdrawal of consent shall not affect the lawfulness of processing that was applied on the basis of consent before its withdrawal.
 11. In order to exercise the rights listed above, you should contact the Administrator (contact details indicated above).
 12. In addition, you have the right to lodge a complaint to the supervisory authority in charge of personal data protection (President of the Office for Personal Data Protection), if you believe that the processing of your data violates the RODO.
 13. Provision of data is voluntary - however, it is necessary to the extent that we process your personal data in order to conclude and perform an agreement with the Administrator (in particular, to the extent necessary for the execution of orders, agreements for participation in the Fair, organization and settlement of the Fair, conferences, accompanying events and other

events), and their failure to provide may result in the refusal to conclude an agreement with you.
