

COMPETITION REGULATIONS:

1. **ORGANISER:** The Competition is organised by Międzynarodowe Targi Gdańskie Spółka Akcyjna [Gdańsk International Fair C.O.] with its registered office in Poland, Gdańsk, ul. Żaglowa 11, entered into the Business Register of the National Court Register [KRS] run by the District Court Gdańsk-North in Gdańsk, 7th Commercial Department of the National Court Register [Sąd Rejonowy Gdańsk-Północ w Gdańsku VII Wydział Gospodarczy Krajowego Rejestru Sądowego], KRS No. 0000038362, VAT No. PL 5840253705, Statistical No. [REGON] 001363012, initial capital of PLN 48.242.650,00 (hereunder: **“the Organiser”**).
2. **DURATION:** The Competition is held in the Republic of Poland and continues from 1 May 2025 until 26 September 2025.
3. The Organiser represents that the Competition is not a gambling, raffle, betting or promotional lottery activity with chance-dependent results, or any other form of a game of chance as construed by the Polish Gambling Law of 19 November 2009 (Journal of Laws 2023, item 227, i.e. as amended).
4. **SUBJECT:** artworks on the theme of: 200 years of railway. Yesterday, Today and Tomorrow.
5. **PARTICIPANTS:** elementary school students, participants in occupational therapy workshops from all over Poland.
6. **The Competition is run in two age groups:**
 - i. grades 0-III (elementary schools)
 - ii. grades IV-VIII (elementary schools) and participants in occupational therapy workshops.
7. **ARTWORK TECHNIQUE:** free.
8. **ARTWORK FORMAT:** A4 or A3.
9. **SUBJECT DESCRIPTION:** The theme is the evolution of rail transportation - from the first steam locomotives, to modern trains, to futuristic visions of railroads of the future. Participants can show their creativity by presenting both history and innovative concepts of rail transportation in their works.
10. **TERMS OF PARTICIPATION:**
 - a. submit entries with a description containing the following details: participant's name and surname, grade, school name and address.
 - b. submit the Information Sheet—Appendix 1,
 - c. submit the Statement—Appendix 2a or Appendix 2b,
 - d. submit the Copyright Transfer Agreement—Appendix 3, together with the entry.
11. **ENTRY SUBMISSION DEADLINE:** 5.09.2025. Please send the entries to:

12. **The entries will be assessed by the Judging Panel** appointed by the Organiser. The Judging Panel's decisions are final.

The jury will evaluate according to the following criteria:
 - a) Compatibility with the theme of the competition,
 - b) Creativity and originality of approach to the topic,

c) Aesthetics and neatness of execution.

13. **PRIZES:** the best entries in their age category will receive the GRAND PRIX. The Judging Panel will award honourable mentions.
14. The prizes are sponsored and will be presented by TRAKO 2025 Exhibitors and Partners.
15. **The Award Ceremony** will be held at TRAKO 2025, the 16th International Railway Fair, on **26 September 2025** in the AMBEREXPO building's ul. Żaglowa 11, Gdańsk, Poland. Laureates will be informed of the results in advance. During the award ceremony, minors will be accompanied by legal representatives.
16. The Competition Participant shall transfer to the Organiser the economic copyright in the submitted entry (including transfer of the ownership of the entered copy) and authorise the Organiser to record (fixate) and reproduce the submitted entry in any technique in accordance with the Agreement which constitutes appendix 3 to these Regulations. The consent also includes the right to make the entry publicly available and to further make use of the copyright. Due to the transfer of copyrights in the submitted entries, the Competition Participant shall not be entitled to any claims against the Organiser and/or any third parties who have acquired such entries (with the exception of the right to obtain a competition prize).
17. The award-winning entries will be presented at the **follow-up exhibition** at the TRAKO 2025.
18. The proceeds from the sale of the works will be entirely allocated to the beneficiary and dedicated to a facility selected by the Program Council that provides psychological or psychiatric support for children and adolescents.
19. **Complaints:** Any complaints regarding the Contest can be submitted in written form, by mail sent to the address of the Organizer's headquarters with the annotation "Contest - complaint", or by e-mail, sent to: [magdalena.okulewicz@amberexpo.pl] writing "Contest - complaint" in the title of the message. In the content of the complaint, you should provide your name and surname, address, the reason for the complaint and the content of the request. Complaints are considered by the Organizer within 14 (fourteen) days from the date of their delivery. The Organizers shall inform the person who filed the complaint about the way the complaint is resolved by the same way the complaint was filed.
20. The Organiser is the controller of the personal data processed in relation to participation in the Competition. The data will be processed only for the purpose of running the Competition in accordance with these Regulations, especially for the purpose of handing out prizes. Data subjects have the right of access to, rectification and/or on-demand erasure of their data.
21. By entering the Competition, the participant accepts the contents of these Regulations and expresses consent to the processing of their personal data contained in the Information Sheet for the purpose of delivering the Competition—in line with the Act of 10 May 2018 (Appendix 1).
22. When participating in the Award Ceremony, the Competition participant and persons accompanying them are obliged to follow the Regulations for Trade and Non-Trade Visitors available at www.trakoexpo.com and to observe all and any epidemic-related procedures.
